Membership

Section 1:

There shall be 3 types of membership, and

Section 2: Trustee Membership

Trustee Membership are members that have a direct membership and fiduciary obligations, and

Section 2(a):

The Obligations of Trustee members have administration duties of YINGLING GARAGE DOORS AND OPENERS, PMA for proper record keeping for the purposes of accounting of books and execution of services in the advancement of equity both scrip and asset, and

Section 2(b):

To maintain and continuation of services for a medium between agents and the clients with the rights to reserve what venue and whatever event that Yingling Garage Doors and Openers, PMA reciprocate services and improve those services with the consideration of new ideas to improve those services. These are members who decide what services Yingling Garage Doors and Openers, PMA offers, and

Section 2(c):

The members of Trustee Membership should have knowledge of the peremptory norms and customs of both private and public international law and in accordance with Scripture, the Law of Nations by Vattel 1758 and human rights under the Universal Declaration of Human Rights, and

Section 5: Client Membership

Client Membership are members who receive a service from Yingling Garage Doors and Openers, PMA, and

Section 5(a):

Client Membership are members that have a contractual membership to apply consideration for performances of the services provided by Yingling Garage Doors and Openers, PMA

Section 5(b):

As members of Client Membership, they have always the right to maintain the freedom of choice in the type of services and products that Yingling Garage Doors and Openers, PMA offer, and

Section 5(c):

As members of Client Membership, they have the option to receive news articles and publishing's, receipts, and inclusive personal records specific to the individual client member only to maintain privacy for all members, and

Section 5(d):

Members within Client Membership shall have a letter of acceptance acknowledging what is to be paid for consideration from the performance for the type of services offered by Yingling Garage Doors and Openers, PMA with a release of liability if the client members services are not of expectation or does not advance from the services and indemnifying Yingling Garage Doors and Openers, PMA with loss of consideration, damages or injury, and

Section 6:

Termination of a member would be for failure to secure the performance in the obligations of one's office, membership, service or consideration, and

Regular meetings shall take place monthly. They shall have a designated date and time the officers shall meet. A report shall be taken by all offices on an account on the condition and status Yingling Garage Doors and Openers, PMA and state. Regular business shall take place in these meetings. There shall be a convening and an adjournment with an announcement to the next convening meeting, and

Section 3:

Annual meetings take place yearly to produce an annual report on the advancement of the equity in growth and loss of scrip and asset, and

Special meetings shall take place on notice and time by the members of Trustee Membership in 2 weeks advance. They are to serve purposes for hosting events, concluding deadlines and special contract, and

Article I

Article VII

Article XIV

Yingling Garage Doors and Openers, PMA recognizes that when in cases of a war of attrition, the acceptance of foreign money may be necessary as a defense to survive which makes it a remedy to do so, and

Article XV

Yingling Garage Doors and Openers, PMA have the right to open up and close bank accounts, and issue security to pay for finance or service, and

Article XVI

The members within Trustee Membership may determine to which court may grant consent judicial powers, and what officers to grant police powers, and what body to grant legislature powers, and what chief to delegate executive powers granted by the Trustee(s) in solely signatory party of the Free Republic Compact of The United States of America within its respected designated State chapter, and

Article XVII

The members within Trustee Membership have the right to collect dues, taxes, fees, fines, and renewals for all services, expanses and products by members within Client Membership, and

Article XVIII

Yingling Garage Doors and Openers, PMA within human rights have the obligation at any time for a reservation of rights in order to enforce all human rights and rights of commerce, and

Article XXII

All associations that have come under the articles of association and bilateral social compact agreement consent to not break any laws that imply a heinous action, that warrants any penal offence, violates human rights, or causes destruction for political motives and is to maintain a free, autonomous but responsible contracts with the services the association offers and customers the association serves, and

Article XXIII

The purposes of services of Yingling Garage Doors and Openers, PMA is to facilitate a more easy, enjoyable and comfortable process to purchase garage door services without the overwhelming obstacles established by political figure-heads with the intent of securing their interests while obstructing fairness in commerce and trade, and

Article XXIV
